Health care is now, without question, the most serious threat to America's national economic security. Over the past decade, \$4 of every \$5 of household incomes growth was absorbed by health care costs, squeezing out other critical needs, like education and infrastructure replacement. Businesses competing in international markets must overcome a 9+% health care cost disadvantage to be on a level playing field with competitors in Australia, Korea or Germany.



We pay double the cost than in other developed nations, and the best studies show that more than half of our spend is unnecessary or provides no value. This is an annual amount equal to 9% of GDP, or our 2012 budget deficit.

Only one group is larger and more powerful than the health care industry, and that's everyone else. Only if America's business community comes together, mobilizing on this problem and becoming a counterweight to the health care industry's influence, can we bring health care back to rights.
