**Dr. Joe Company, PhD –** *Co-Owner & Founder Wellness Data Solutions, Endurance Company, LLC.* Dr. Company co-founded the data-driven, outcome based wellness system, Wellness Data Solutions. He provide scientific, health-focused medical input on our wellness system. This includes: overseeing the analytical side of the wellness program, writing scientific articles, designing health and wellness programs, performing biometric screens and analyzing biometric data, present data to business owners and groups, perform metabolic tests including sub-max VO2, substrate utilization testing, 'fat max testing,' and resting metabolic rate, and marketing our entre wellness system.

Dr. Company is also the owner of Endurance Company, LLC, Bloomington, IL. He oversees all operations at Endurance Company including sub-contracting coaches, partner relations, local programming, camps and destination activities, and personal coaching. He works with a limited number of personal clients where he offers custom-designed endurance performance training programs. This includes daily training plans, data collection and analysis, frequent interaction with athletes both in person and by email, text, and phone, one-on-one coaching sessions, performance nutrition counseling, laboratory metabolic testing, laboratory and field performance testing, education, training camps, and race-day support. Dr. Company collaborates with two licensed dietitians, a sports psychologist, a professional swim coach, a professional cycling coach, a chiropractor, a physical therapist, and orthopedic doctors to provide athletes with a variety of services to optimize their performance potential. He also collaborates with various companies in the endurance industry (cycling, clothing, equipment, nutrition, DNA testing etc.) for personal and team sponsorship and assure that the relationship is mutually beneficial for the industry company, my business, and my athletes.

He did a Doctorate in Biomedical Sciences at the University of Missouri, Columbia, MO in the Department of Biomedical Sciences. Dr. Company was in charge of his own experimental study design for my dissertation project. This included: obtaining grant funding, animal husbandry, data collection, data analysis, overseeing and managing undergraduate workers who were assigned to work with me on my project, writing all manuscripts from my data, and collaborating with co-authors. In addition, he contributed to other study





designs and data collection in our laboratory, collaborated with students and post-docs on their projects, collaborated with investigators from other laboratories and other universities on research and manuscript writing, and worked with my advisor, Dr. Frank Booth, on conference presentations, grant-writing, and lab management.

Dr. Company did Master's research in Exercise Physiology at University of Missouri, Columbia, MO in the Department of Nutrition and Exercise Physiology. He worked with an ongoing departmental project investigating the effects of diet- and exercise-induced weight loss followed by weight regain in subjects with the metabolic syndrome. This included metabolic tests and analysis, nutrition counseling, and exercise counseling. I also designed my thesis study, which involved body composition measurements on 93 student and adult athletes, recruited subjects, collected data, managed undergraduate students assigned to assist me in my thesis project, and published a manuscript from my thesis data. His data also won the 2008 ACSM Central States Master's Research Award.
